## Roy P. Drachman Stadium


The 2011 season will mark the 30th anniversary of Roy P. Drachman Stadium as home of the Arizona Wildcat track and field program. In 1981, the Wildcats moved from Arizona Stadium to the current location at 15th Street and Plumer Avenue. The facility first took the name of Rincon Vista Stadium. However, several years ago, thanks to generous donations that allowed the facility to be upgraded, the Arizona Athletics Department renamed the Wildcats' home the Roy P. Drachman Track and Field Stadium.

Considered one of the fastest and most functionally designed complexes in the country, the stadium has played host to several outstanding track and field meets. The list includes the 2003, 1995 and 1985 Pac-10 Championships, the 1987 TAC Junior and Intermediate Championships, the 1983 WCAA Championships and the annual Arizona Jim Click Invitational and Willie Williams Classic, as well as several other events throughout the year.

The stadium was completely overhauled during the fall of 2006 and is now a state-of-the-art facility with a nine-lane Tartan track and the latest design in field event competition areas. The high jump apron has been expanded and all the runways were resurfaced with a Tartan surface. The entire facility is now hard-wired with a flawless Hy-Tek electronic timing system which produces accurate electronic times.

In 1989, a computerized scoreboard was installed at the southeast corner of the track. Its features include a timing clock, message board and capabilities to generate updated team and individual results.

The seating capacity of Drachman Stadium is more than 5,000. The largest crowd to attend an event at the complex was a standing room only crowd estimated at more than 6,000 people at the 1988 Tucson Elite Classic.

Long Jump: (Northeast Pit): The take-off board is located six feet from the sandpit with 138 feet of approach.  
Women's Triple Jump: (Northeast Pit): The take-off board is 36 feet from the sandpit with 110 feet of approach.  
High Jump: A large rectangle, which can be used in any direction, and has a minimum of 27 feet on any side of the standards.  
Pole Vault: 145 feet of approach from north to south and 152 feet available from south to north  
\*These are the recommended pits for use during the Championships.

## Championships A-Z

### Athlete Flow:

The clerk of the course and field event check-in will be located on Murphey Soccer field. Student-athletes competing in both running events and field events at the same time must check in at the initial clerks tent and, when escorted onto the infield for field event, they must get their hip number for their race at the final staging tent. They are responsible for reporting to the starting line for their running event.

#### Running Events:

1st Call	60 minutes prior to start of the event
2nd Call	30 minutes prior to start of the event
3rd Call	15 minutes prior to start of the event
Final Report Time	10 minutes prior to start of the event – Report to Final Staging Area

#### Field Events:

1st Call	90 minutes prior to start of the event (Throws & Horizontal Jumps) 2 hours prior to start of the event (Pole Vault)
2nd Call	60 minutes prior to start of the event (Throws & Horizontal Jumps) (pits are open for warm-ups at this time) 90 minutes prior to start of the event (Pole Vault) (pits are open for warm-ups at this time)

### Awards:

The top three finishers in each individual event and each relay event will be recognized and awarded their medals through out the championships, specifically after each final event. Additionally, awards will be given out to the Male and Female Athlete of the Meet, based on the amount of points scored, and team trophies will be presented at the end of competition.

### Facility Hours:

Roy P. Drachman Stadium will be available for entry to spectators 60 minutes prior to the start of competition on each day.

### Coaches Boxes:

Coaches will NOT be allowed on the track and/or infield. Please instruct student-athletes, athletic trainers, managers, etc. to stay behind the fence that circles the track when not in competition or attending to an injured student-athlete. There will be coaches' boxes set up for the pole vault only to be utilized during the warm-ups but they will be asked to leave the infield at the start of the event.

### Coaches' Meetings:

The coaches' lunch/meeting prior to the combined events championship weekend will be held Fri., May 6, at 1 p.m., at the Soccer Team Room/Murphey Soccer Complex. The coaches' dinner/meeting prior to the track and field championship weekend will be held Thurs., May 12, at 6:30 p.m., at the Viscount Suite Hotel.

### Competition Bibs:

Competition bibs for each participating student-athlete will be included in the team packets along with eight (8) safety pins per competitor. These bibs must be worn on the front and the back of the uniform jersey during competition. In the pole vault, the bib should be worn on the back only. In the high jump, the bib should be worn on the front only. BIBS CAN NOT BE ALTERED IN ANY FASHION.

### Credentials:

Credentials will be distributed in the team packets for coaches, medical staff and team personnel. Student-athletes will be given wrist bands, also in the team packets. Credentials must be displayed to enter the facility, warm-up area, media area and athletic training area. Everyone must have their credential for re-entry to Roy P. Drachman Stadium.

### Declarations:

Declarations will be handled by Direct Athletics and open on Thurs., April 28. Declarations are due by 12 p.m. on May 3 for the combined events weekend and by 12 p.m. on Tues., May 10 for the track and field weekend. After the deadline, the Pac-10 Conference office will contact each institution to confirm the entry list.

### Electronic Devices:

NCAA and Pac-10 Conference regulations state that the use of personal stereo devices (e.g. walkmans, portable CD players, headsets, ipods, etc.) and cell phones are prohibited in the official warm-up and competitive areas for both regular season and conference championships. The meet referee will issue a warning to anyone using such a device. A second violation of the rule at the same meet will result in a disqualification from the meet. At Roy P. Drachman Stadium, this includes anywhere within the stadium fences and the warm-up area at Murphey Soccer Complex, with the exception of the athletic training area, bleachers and spectator area on the east side of the stadium.

### Eligibility:

All student-athletes must be certified as eligible by the institution as required by the Pac-10 Conference office prior to participating in the Pac-10 Outdoor Championships. Each institution is allowed to compete 28 student-athletes per gender.

## Championships A-Z

### Entering Roy P. Drachman Stadium:

Coaches and student-athletes may only enter Roy P. Drachman Stadium on the north end, closest to 15th Street. All credentialed student-athletes and team personnel will be allowed access through the parking lot located between the Roy P. Drachman Stadium and Murphey Soccer Complex. The final staging area and the infield can be accessed through the allotted gate on the northeast corner of the stadium. The final staging area is located at the start of the 100 meters.

### Equipment (Starting Blocks & Batons):

All starting blocks will be provided on site by the host. Relay teams should supply their own batons.

### Heat Sheets/Results:

Heat sheets and results will be posted on the results board, located on the south end of the west stands, in the warm-up area, and at the protest table (south end of the west stands). At the end of each day of competition, heat sheets for the next day and results from that day will be available to coaches at the protest table one hour after the final event of the day is contested. Results and heat sheets will be also posted on the web at [ArizonaWildcats.com](http://ArizonaWildcats.com).

### Hospitality:

The hospitality tent, available to officials, coaches, team personnel, SIDs, media and VIP, will be located directly south of the student-athlete drop-off area in between Roy P. Drachman Stadium and Murphey Soccer Complex. Student-athlete hospitality will be located on Murphey Soccer Field. A detailed schedule of hospitality hours will be available on-site.

### Implement Weigh-In/Inspection:

Inspection and weigh-in for all throwing implements (open and combined events) will take place on the east side of Roy P. Drachman Stadium, in between Murphey Soccer Complex. All implements will be impounded at the time of weigh-in. Only certified implements may be used during official warm-ups and competition. All implements may be picked up at the weigh station after the conclusion of the event final. Weigh-ins will be conducted:

### Lost and Found:

Lost and found will be kept by meet management and will be housed in the white building at the southwest corner of the stadium.

### Mixed Zone:

The mixed zone is located at the south end of Roy P. Drachman Stadium. After the completion of their heat or flight, student-athletes will be brought directly to the mixed zone from their competition venues. The mixed zone will be split in half - on one half will be the basket pick-up area and the other half will be an area for media members to contact individual student-athletes.

### Official Meet Web Site:

The official meet web site is [ArizonaWildcats.com](http://ArizonaWildcats.com). Meet info, start lists and results will be available on the official meet site as soon as possible.

### Parking and Directions:

Roy P. Drachman Stadium is located at 15th Street and Plumer Avenue, next to the Murphey Soccer Complex, roughly two miles from the University of Arizona campus.

Parking for teams and officials is located on the grass lawn at Rincon Vista, east of Roy P. Drachman Stadium, and a parking pass will be required for entry. Media parking is located on the northwest corner of the stadium and a parking pass will be required for entry. The student-athlete drop-off zone is located at the north end of the stadium on 15th Street. Public parking is located in the UA CatTran Carpool Lot, at 14th Street and Plumer Avenue.

### Pass List:

Competing teams may submit their pass list to Ben Smith in the Arizona Ticket Office. Lists may be emailed to [bmsmith1@email.arizona.edu](mailto:bmsmith1@email.arizona.edu) no later than Wed., May 12, at 5 p.m. PT. The Arizona Ticket Office will send competing schools an invoice for the tickets used. Payment is due no later than Wed., June 15. At Roy P. Drachman Stadium, the pass list will be located at the ticket booth at the southwest corner of the stadium, closest to the public entrance. A photo ID will be necessary to gain entrance using the pass list.

### Pole Vault/Poles Storage:

Coaches are instructed to make arrangements with their hotels for the shipping of pole vault poles. Vaulting poles will be stored under the north end of the southwest grandstands.

### Preferred Lanes:

When preferred lanes are needed for seeding purposes, the following will be used: 5-6-4-7-3-8-2-9-1.

## Championships A-Z

### Protest Table:

The protest table will be located on the south end of the west stands. Protests must be made in writing on the official protest form which will be available at the protest table. Consult the 2011 NCAA Rules Book for explanation. The referee's decision will be posted directly behind the protest table as soon as the information is available.

### Results/Timing:

University of Arizona staff will handle timing and results for the combined event championships. Roger Jennings and Flash Results will handle all the entries, timing and results for the track and field event championships.

### Relay Cards:

Relay Cards will be completed by the coaches during the coaches' meeting on Thurs., May 12. In order to provide accurate relay names/order to the FSN crew, changes in relay teams must be reported to the clerk 15 minutes prior to the race.

### Spikes:

1/4' pyramid and Christmas tree spikes are preferred on the track at Roy P. Drachman Stadium.

### Student-Athlete/Team Seating:

Student-athlete seating will be located in the bleachers at the backstretch of the facility (east side of the stadium). This is the only location that student-athletes will be allowed to view the meet inside the stadium.

### Team Packets:

Team packets may be picked up at each coaches' meeting. Coaches may expect to find the following in each packet:

### Team/Bus Parking:

Parking for teams and team buses is located on the grass lawn at Rincon Vista, east of Roy P. Drachman Stadium, and a parking pass will be required for entry. The student-athlete drop-off zone is located at the north end of the stadium on 15th Street.

### Team Tents:

Teams will be allowed to set-up their tents in the northwest corner of the stadium or along the east side of the warm-up track (pop-up tents only near the warm-up track). To order a tent for your team, please contact Arizona Party Rentals at 520-327 6678.

### Tickets:

Tickets for the championship may be purchased from the Arizona Ticket Office or online at ArizonaWildcats. com. Tickets will be available to purchase at Roy P. Drachman Stadium one hour prior to the first event each day of competition. Ticket prices are listed below:

\$10 per day for adults; \$5 per day for youth and seniors
\$15 two-day package for adults; \$8 two-day package for youth and seniors

### Warm-Up and Cool Down:

No warm-ups are permitted on the track at any time. Murphey Soccer Complex will be used for warm-up and cool-down, located on the east side of the stadium. Blocks and hurdles will be provided and there will be lanes in the middle of the soccer field and an oval laid out.

## Medical Services/Athletic Training

### Athletic Training Areas:

The athletic training area will be located in a medical tent on the northwest corner of the Murphey Soccer Field. Supplies that will be available in the athletic training area include a hydrocollator, ultrasound, electrical stimulation, ice, ice tub and first aid supplies. A team physician will be on site or on call throughout the championships.

Please notify Rita Chorba (rchorba@email.arizona.edu) if you will be requiring additional supplies or services, such as rehabilitation equipment or various other modalities. If your team is not traveling with a Certified Athletic Trainer, a written request for the application of therapeutic modalities will be necessary.

- Two Certified Athletic Trainers will be present at all times
- Athletic Training Student Technicians assistance
- Access to a medical tent with tables, modalities and supplies
- Water, cups, injury ice, ice bags
- Biohazard kits
- Team Physician will be on call or on site
- Emergency station located near the finish line under the west grandstands

EMS personnel will be located behind the west grandstands for injuries occurring to or assistance needed by competing athletes.

### Competition Emergency Center:

Student-athletes who are injured within the oval will be triaged and brought to the edge by Arizona medical staff. An emergency treatment center will be located under the west grandstands with emergency cold tubs, oxygen, vacuum splints, AED and emergency bag.

### Athletic Training/Massage Tables:

Athletic training and massage tables will only be allowed to set-up in the medical tent area in the northwest corner of Murphey Soccer Stadium.

### Credentials:

Please work with the institution's SID or media relations representative on site for additional interview requests.

### Parking:

Roy P. Drachman Stadium is located at 15th Street and Plumer Avenue, next to the Murphey Soccer Complex, roughly two miles from the University of Arizona campus. Media parking is located on the northwest corner of the stadium and a parking pass will be required for entry.


