## About Wildcat Golf Camp

The Wildcat Golf Camp will focus on the development of each golfer as well as concentrating on the technical and fun aspects of the sport. The golf facility at Arizona National "Home of the Wildcats" is one of the finest in the country for collegiate athletics.

#### **Eligibility**

All Junior High and High School boys and girls including recently graduated high school seniors who have not yet started a 2 year or 4 year school. Those enrolled in college or those with NCAA eligibility remaining are not allowed to attend.

#### **Camp Size**

Campers will be tested and grouped according to ability for the time of camp. Each camp session will be limited to the first 40 campers.

Men's Head Coach

Entering his 22<sup>nd</sup> season at the helm of the Wildcats, Rick LaRose, director of golf and head coach of Arizona men's golf teams, has established the Wildcat golf program as one of the nation's best. The only coach

in collegiate history to win both a men's and women's NCAA golf title, he has consistently produced winning programs and individual golfers who have been among the country's elite.

LaRose's teams have won two NCAA titles (1992 men's/ 1996 women's), six NCAA regional championships, five Pac-10 crowns and two Rolex Match Play titles. He has also produced five national player of the years, seven Pac-10 Players of the Year, 53 All-Americans and 74 All-Pac-10 Conference performers. His players have left their mark on the professional tours, with such players as Jim Furyk, Robert Gamez, Mike Springer, Larry Silveira, Manny Zerman, David Berganio and most recently Rory Sabbatini carrying on the UA golf tradition in the pro ranks.



**Greg Allen**Women's Head Coach

Greg Allen was named head coach of Arizona's women's golf team in July 2000 after two years as the assistant coach for the University of Texas men's golf program. While at Texas, Allen was instrumental in the development of the Longhorn Junior

Golf Camp and was the assistant while PGA Tour player and 1999 U.S. Amateur Champion David Gossett played on the team. Prior to his arrival at Texas, Allen spent five years as both director of tournament operations and tournament director for the American Junior Golf Association (AJGA).

Under Allen's leadership, the current Wildcat team will be trying for the school's fourth consecutive Pac-10 title, third NCAA Regional Championship and third NCAA Championship. Allen helped Lorena Ochoa reach the pinnacle of the collegiate golf scene as she was named 2001 Player of the Year, 2001Freshman of the Year and 2002 NGCA Collegiate Golfer of the year. Ochoa and former Wildcat Natalie Gulbis both earned All-America honors under Allen.

#### Camp Fees

\$900 per week. Camp cost includes all instruction, green fees, range balls, room and meals.

#### Deposit

A \$200 non-refundable deposit (which is applied to the camp fee) must accompany each application. Upon receipt of your registration, medical release form and deposit, we will send you a letter of confirmation. It will note your registration for each session. Additional information relative to your attendance will be enclosed. Please keep this and bring it with you to the check-in table. There will be a waiting list created for each session upon full enrollment. All fees, registration, and medical information must be completed at the time of check-in.

#### Meals and Housing

Campers will stay at the DoubleTree Guest Suites located near Arizona National Golf Club. Boys and girls are housed separately and assigned two-to-a-room according to age or individual roommate requests. Breakfast, lunch, and dinner will be provided for all campers. All meals will be served either at the hotel or golf course. The DoubleTree Guest Suites features a swimming pool and fitness center and is near a shopping center and movie theater.

#### Airport Transportation

For those flying, transportation will be provided to and from Tucson International Airport. Campers will be met by a counselor at the baggage claim area upon arrival.

#### Registration

Registration will be 1:00 - 3:00 p.m. at the DoubleTree Guest Suites lobby on Sunday. The remaining balance will be due at this time.

#### Supervision

Campers will be supervised at all times. Counselors will be staying at the hotel with campers.

#### First Aid

An Arizona athletic trainer will be on duty to treat all minor injuries and sickness. For serious problems, campers will be taken to the nearest Urgent Care Center.
